## **Global Payroll Management**

Payroll previews, instructions, and compensation files including all elements of pay, both cash and non-cash, are recorded accurately to maintain regulatory compliance.

#### **Key Deliverables**

#### **Payroll Preview**

- Generate current month pay run preview, including comparison of current to previous month
- Review and validate payroll preview discrepancies including resolving predicted payroll errors

#### **Payroll Instructions**

- Create payroll instructions validated against the approved preview
- Calculate US gross-ups and/or withholding tax (optional)
- · Initiate necessary file or feed transfer to local payroll providers

#### **Compensation Collection Files**

- Review and validate amounts instructed against amounts paid
- Liaise with customer to reconcile and clear differences
- · Create adjustments in following pay period as needed
- Collect third party expenses including relocation, immigration, and tax payments

#### Shadow Payroll

- Created for each host location, where required
- Run at the end of the month after all compensation has been audited and committed

# **Global Expense Management**

#### **Key Deliverables**

#### **Quality Review**

- Review expense submissions for completeness
- Liaise with expense submitter to obtain additional information as needed

#### Policy Review

# **Accrual and Finance Management**

The combination of Topia Plan's cost estimate capability and Topia Pay with Global Payroll Management services enables easy management of financial accruals associated with a global mobility program.

### **Key Deliverables**

#### **Initial Accruals**

 Generate accrual reports based on approved assignee cost estimates

#### Cost Estimate Revaluation

 Manage recalculation of cost estimates and balance sheets due to changes in compensation, rates or employee life events

#### **Budget to Actual Reporting**

 Leverage compensation and costs imported into Topia Pay to compare actual costs against approved cost estimate (budget) on a per assignment basis

#### Accrual adjustments

 Reporting provided to global finance teams of adjustments to current and future financial period accruals
